Boy, Recovered From Polio, Aids March Of Dimes

ATLANTA, (AP)—The boy, lively as a cricket, lap-danced briskly before the television cameras five years ago. Ed Bernd, Jr., 10, was almost completely paralyzed by polio. He couldn't even lift his chin.

But he emerged from his battle with the crippling disease sound in body and grateful of heart. Ed's successful fight was directed by the Georgia Chapter of the National Foundation for Infantile Paralysis. The Atlanta Journal told of the fight in a feature story today.

The youngster, who had a "complete recovery" from his severe attack of polio is lucky — and he knows it.

Now he is busy with plans to help other victims by boosting the March of Dimes.

Before Ed was out of his wheelchair and getting well enough to ride in a wheel chair was a triumph in itself, he contributed the contents of his piggy bank to the annual campaign. Last year with a classmate, Billy Williams he put on a show at R. L. Hope school and raised nearly \$200.

Radio and TV appearances seemed the best idea for 1951. He wanted "to reach more people," he explained gravely.

Ed's enthusiasm for the cause which turned him from a helpless cripple to the active energetic boy he had before his illness is intense — and sincere.

He frequently revisits the doctor and the therapists to whom he owes so much. And he keeps busy with his March of Dimes projects — all of them his own ideas.

"I'm awfully glad I had polio, because I have a chance to help," Ed said solemnly.

Right Negroes Vote In Texas Primary Upheld

U. S. Fifth Circuit Court Of Appeals Re-Affirms Decision

NEW ORLEANS, (AP)—The right of Negroes to vote in Texas primary elections has been re-affirmed by the U. S. Fifth Circuit Court of Appeals here.

In a decision handed down yesterday, the court held that qualified Negroes must be allowed to vote in primaries of the Citizens Party of Harrison county, Texas.

The decision was in the case of James E. Perry and James McCrary, Negroes, vs. J. W. Cyphers and others. Cyphers was chairman of the Citizens Party of Harrison county, a political group created during Civil War Reconstruction Days, designed to overcome carpetbag rule.

Cyphers said at Marshall, Tex., last night that as soon as his counsel reported he would call a mass meeting of the party to consider what will be done. His attorneys said they would have to read the full opinion before making recommendations to the party.

Harrison county, with Marshall as the county seat, has a predominant Negro population. Elections conducted by the party frequently were referred to as "the white man's primary."

Cyphers and his co-defendants argued the two Negroes were not eligible to vote because they were not party members and could not vote because of their race and color. They argued that this was contrary to the Fifteenth Amendment to the Federal Constitution.

The defendants admitted barring the Negroes from voting in the party primary because of their race and color, but contended they were acting as heads of a

non-public group, not as administrative officers of the State of Texas.

A Texas Judge, U. S. District Judge Whitfield Davidson, ruled in favor of Cyphers. He dismissed the Negroes suit on the ground they had not been deprived of a vote in Harrison county affairs. The court pointed out that the Negroes still retained the right to vote in the general election. Judge Davidson found they had failed to take advantage of other voting privileges available to them under the law, such as forming their own party.
